Deadline for Entries is January 19, 2024 via online consignment form

1. Nomination Fee: \$100/head that will be credited towards sale commission. Must be paid at entry online. Scratched lots will forfeit the Nomination Fee. **Sale commission at or near 15%.**
 - a. Nomination Fee covers stall fee, bedding, transfer and Checkoff fees.
 - b. Substitute lots are allowed. Prior notice is required.
2. All cattle must be halter broke. All cattle must be clipped and in presentable condition.
3. All sale cattle must participate in the buyer review opportunities. Sale cattle do not need to be groomed for the buyer review times. The buyer review times are:
 - a. Thursday, March 14, 2024
 - b. Friday, March 15, 2024
4. Cattle which can be consigned:
 - a. Registered Red Angus Bulls born after January 1, 2022.
 - i. Bulls born in 2023 should be ready for service on Sale Day, March 15, 2024.
 - ii. All sale bulls over 18 months and all non-virgin bulls are required to have a negative trichomoniasis PCR test by March 13, 2024.
 - iii. All bulls are required to be tested for Bovine Viral Diarrhea (BVD) persistent infection (PI) status and have a negative result by March 13, 2024.
 - iv. All bulls must pass a BSE (Breeding Soundness Exam) that includes a minimum of 30 cm SC measurement, adequate semen morphology and motility and physical characteristics. A BSE exam paper showing the above information and that he is a satisfactory potential breeder must accompany each bull to the sale.
 - v. Each consignor is limited to 5 bulls in the sale.
 - b. Registered Red Angus Females born after January 1, 2018. Embryo transplants/recipients, and pregnancies are eligible.
 - i. All females are required to be tested for Bovine Viral Diarrhea (BVD) persistent infection (PI) status and have a negative result by March 13, 2024
5. Sale Order will be determined by sale management and the auctioneer. All sale lots will sell as individuals. There will be no groups or buyer's choice.
6. In case of excess numbers consigned to the 2024 Red Wave Sale, the sales management reserves the right to review entries and screen if necessary. Preference will be given to older cattle and in-state consignors.
7. By January 19, 2024, each entry must have:
 - a. \$100 nomination fee
 - b. Registration number
 - c. Footnote information

8. By February 5, 2024, each entry must have to sales management:
 - a. Digital photos for sale catalog
 - b. Sale video footage. CCI has been awarded the on-line sales contract for 2024.
9. Please carefully review health requirements for the sale. Highlights include:
 - a. All cattle must be tagged with 840 RFID tags (this also requires a premise ID to get the 840 tags)
 - b. Negative for Bovine Viral Diarrhea (BVD) persistent infection (PI).
 - c. Meet appropriate Brucellosis and Tuberculosis requirements.
 - d. Properly filled out CVI by your veterinarian.
 - e. Negative trichomoniasis results for all bulls that are non-virgin or 18 mo old or greater.
10. All Red Angus cattle must arrive to the Ohio Beef Expo grounds on Wednesday, March 13, 2023.
